

Lennox Manufacturer Certification Statement Under American Taxpayer Relief Act of 2012

FEDERAL TAX CREDITS FOR QUALIFIED ENERGY-EFFICIENT HVAC IMPROVEMENTS—DUCTLESS MINI-SPLIT AIR CONDITIONERS AND HEAT PUMPS PRODUCT CATEGORIES

Taxpayers claiming a credit for Qualified Energy Property should retain this Certification Statement for taxpayer records.

Under the American Taxpayer Relief Act of 2012, the U.S. Internal Revenue Service (IRS) is implementing consumer tax credits for homeowners who make qualified improvements of higher-efficiency HVAC equipment to their primary residences. Tax credits are effective for all qualified energy property systems installed from January 1, 2012 through December 31, 2016.


